There are some very exciting projects being looked at by the Board and the Charitable Trust. The most exciting proposal would be to sequence the Great Dane Genome. This is only in the discussion stage but we could see a proposal in the next 12 months. The benefits could be enormous. Just the fact that the information gained would help every researcher who is studying diseases that affect our guys is enough justification to fund the research. This will help with DCM, Wobblers, HOD and so much more.

The second project which is just as exciting is funding the continued research of Kate Meurs in searching for the gene responsible for DCM in Great Danes. Many of you have joined discussions on the boards about the longevity of our breed. Help support the research that is being done into the diseases that take so many of our guys.

AKC has approved the changes to the standard which were submitted to them in January. Now it is our turn to vote on those changes. The ballots will be in the mail to all of you in June. Please remember the proposed changes came from the membership. I urge all of you to support them.

The ballots for the 2012 judging slate will be coming to you shortly. We have over 800 members and only about 50% of you vote. You cannot change the outcome of anything if you do not participate.

For those of you who participate in the Futurity please remember that Dianne Powers is the new Futurity chairperson as of May 1st. Check our website for Dianne's contact information. I have enjoyed being your futurity chair for the last six years and wish all of you good luck.

The next board meeting will be on July 24th in Boston. As always we welcome all members to these meetings.

It is such a pleasure to hear from so many of you with your ideas for a better Dane community. The final revision of the National Specialty rules is in process and should be published by mid summer.

AFFILIATE CLUB REPORT

The revised by-laws for the Great Dane Club of El Paso and the Heart of Ohio Great Dane Club were approved at the April Board meeting. Congratulations to both clubs for a great job.

As I have mentioned this will be my last year as your Affiliate Representative. Our by-laws stipulate no more than 9 consecu-

tive years for Board members.

This means that a new Representative will need to be elected.

Anyone interested will need to be willing to attend the Board meetings (4 times per year) and make themselves available to questions from the Affiliate Clubs. I have found it to be a wonderful experience and will miss it. If you have any questions about the position or the election please contact me

The process for the election is as follows:

Election of the Affiliate Club Representative (ACR):

1. The Affiliate Club Delegates Committee (ACDC) secretary, during the election year, shall receive and accept written nominations for the office of ACR. Such nominations must be submitted before August 15 of the election year, accompanied by the written consent and signature of each nominee.
2. The name of any affiliate club member, who is also a member of the GDCA, in good standing with his/her affiliate club and the GDCA, can be placed in nomination.
3. The ACDC secretary shall mail the list of such nominees and a voting ballot to each Delegate by August 27 of the election year. It will be the Delegate's responsibility to present the slate to his/her club for consideration/direction of the election of one (1) candidate. Each Delegate will then mark the ballot, sign same and have the affiliate club secretary certify the bal-

lot by signing the front of the ballot before it is placed in the envelope and sealed. The ballot must be returned to the ACDC secretary before October 10 of the election year.

The ballots **MUST BE SEALED** if more than one candidate is nominated.

NOTE: If the ACDC secretary is one of the nominees, another person shall be appointed by the ACDC to perform all functions for the election normally performed by the secretary.

4. The counting of the votes to verify election results of the ACR shall be done by the ACDC secretary (or

acting secretary) in the presence of a Notary Public. Said secretary shall immediately inform the ACR of the results so the ACR can then notify the Delegates, newly elected ACR, and the GDCA secretary of the ACDC choice for Representative.

5. No person shall serve more than three (3) consecutive three year terms as ACR.

Please give some serious thought to who you would like to have representing you on the GDCA Board.

"Helping Our Own"

Many members of the GDCA have aspirations of becoming a judge. An important aspect of your initial application is your ring experience in the form of matches and sweepstakes. Too often the various affiliate clubs do not know the names of our own members that are desirous of a sweepstakes assignment in order to bolster their future application. As a point of interest, your application should contain a minimum of six actual judging assignments. However, a sweeps assignment or specialty match counts as two match assignments. In order to try to get our own (hence the title of this program) these assignments we will begin to accumulate the names of those GDCA members that have aspirations of applying to judge Great Danes.



Individuals that are planning to submit their application within a year have probably already accumulated their necessary requirements and the logistics of compiling this list as well as the individual clubs going through the panels that are already in place would mean that at least 12 months will pass before most clubs would be able to utilize this information. I will maintain this list for the GDCA and updated versions will be sent to the affiliate clubs via their periodic newsletter.

For those that have aspirations of judging but may not have investigated the requirements of the AKC, here is some basic info...

The "current" system (always a work in process) requires 12 years in the breed, 5 litters and 4 champions of record. Keep in mind that these are the MINIMUM REQUIREMENTS!!! In addition you need to show total dog show experience in the form of match/sweeps assignments, stewarding, club membership, seminars (either as an attendee or presenter), etc. The more activity you can document, the better.

If you are interested in judging and would like to be included on this list, please send me your name, and contact information. Hopefully this will make life a little easier for our future member-judges.
