AFFILIATE CLUB REPORT

Affiliate Club Representative Report – October 2010

First I would like to welcome Dale Tarbox as the newly elected Affiliate Club Representative. I am confident that she will do a great job serving the interests of the Affiliate Clubs. Delegates, please introduce yourselves to her over the next couple of months.

The Wolverine Great Dane Club will be submitting revised bylaws that need a few revisions. They have agreed to the changes and will be taking it to their membership for approval at their November meeting and will forward the revised set of bylaws after the club vote. At that point I would expect that there will be a request for an electronic vote to approve the bylaws.

Another item in process is an educational grant request from GDC of Des Moines which will be ready for Board review at the January meeting.

I have been fortunate enough to have served as Affiliate Club Representative at an exciting time. In the past 9 years the GDCA has made some changes that had direct impact on the Clubs. Since the approval of the revised GDCA bylaws in 2005, which allowed the Affiliate Clubs to craft their own by-laws, we have 14 clubs complete the revision process and have updated bylaws and others are in process. I am particularly proud of a couple of the clubs who were the front runners in crafting language regarding rescue and on-line meeting formats. Those languages have been picked up by several of the clubs and I believe will become a part of many sets of bylaws.

In January of 2001 the GDCA voted to allocate funds to be used by Affiliate Clubs to support educational programs and health related projects. Since then 19 clubs have taken advantage of these grants, some multiple times. To date, the GDCA and the Charitable Trust have granted in excess of \$15,000.00 for these programs.

During these past 9 years we have lost 1 club (Tidewater) but we gained 4 (Heart of Texas, Mat-Su Alaska, Oklahoma and Central North Carolina). We have also had a preliminary inquiry from the Caribbean Great Dane Club in Puerto Rico.

Thank all of you for a wonderful 9 years. I treasure the friendships I have made while trying to help your clubs. It has been my pleasure to serve all of you.



HEALTH AND WELFARE REPORT **IP YOUSHA FUNDING REQUEST FOR THE GREAT DANE GENOME: Dr.** Leigh Anne Clark of Clemson University (who discovered both the merle & harl genes) has requested funding to specifically sequence the genome of the Great Dane. Dr. Clark has received support from other parent clubs to sequence specific breeds (namely the Collie and the Irish Setter). Her proposal for the Great Dane would include a genome comparison between Danes with dilated cardiomyopathy and veteran Danes with a recent normal echocardiogram. Her estimated time frame is 2 vears and cost estimate is under \$50,000. This type of project can both elucidate specific disease and provide general insight into potential target genes for various diseases. It would also help focus other research efforts on our breed as a breed specific sequenced genome potentially provides other researchers with advanced information from their various areas of interest. For these reasons, funding a breed-specific genome project should be a priority. Recent advances in sequencing techniques and increasing interest in the dog as a model organism for research into human disease make this an ideal time to begin such a project. FUND-ING REQUEST FOR WOB-BLER SYNDROME: Dr. Ronaldo da Costa has requested funding for Wobbler's dis-

ease from the Charitable Trust (CT). Dr. da Costa is

an Assistant Professor at Ohio State University and has been engaged in research into both the cause and treatment of Wobblers syndrome disease in both the Doberman Pinscher and Great Dane for several years now and has extensive publications to day on the topic. Dr. da Costa traveled to the 2010 National Specialty to meet with board members and give a talk on Wobblers to the general membership. A detailed prospectus for his study and financial needs has been supplied to the boards of the GDCA & CT directly. This research would have to be directly funding by the Charitable Trust.

OTHER POTENTIAL RESEARCH **NEEDING FUNDS:** Dr Leigh Anne Clark is currently working on the topic of congenital (juvenile) megaesophagus in the German Shepherd Dog (GSD) and has asked if we would be interested in funding research into this disease in the Great Dane. She would require contrast radiographs (barium swallow) on all puppies in litters where mega is identified and would then collect DNA (blood) samples from affected puppies (including those identified as affected by radiograph), with the idea being to isolate the mode of inheritance and ultimately the specific genes involved. Currently she is collecting samples (free of charge) from a Dane family I located for her to compare them to the haplotype found in the GSD. The results of this work will be reported back to me with her recommendations for the next step (which would presumably then involve a funding request).

ONGOING RESEARCH REQUEST-ING SAMPLES (no funds currently requested): Dr. Alison Starr of Clemson University is continuing to accept DNA (blood or buccal swab) samples from any puppies currently suffering from hypertropic osteodystrophy (HOD) as well as any adult Danes that survived HOD. Purina Pro Club Newsletter recently interviewed Dr. Starr and a publication on the topic is pending and will be available at the GDCA website in early 2011. Dr. Anita Oberbauer of UCDavis has made recent advances in identifying candidate genes for Addison's disease in several breeds, and this may ultimately also benefit our breed (she can, for example, test those specific genes against Danes entered in the study), however advances in our breed are still hampered by the lack of enough affected (Addison's) Danes entered into the study. There is a link at the front page of the Health & Welfare section at the GDCA website that provides comprehensive information on this research. Research into the genetics of dilated cardiomyopathy (DCM) by Drs. Kathryn Meurs and Mark Oyama is ongoing and currently focusing on candidate genes. Samples from healthy veterans as well as DCM affected Danes are requested. A page on this research is available at the H&W section of the GDCA website. Dr. John Rossmeisl is still seeking samples from Danes with the rare breed disease called orthostatic tremor. Dr. Loechel of VetGen is still in need of samples from Danes with von Willebrand's disease (only 2 affected Danes in 2 years have offered him samples). He would like to have RNA samples from known carriers as well for a new approach to the problem. Again, information on submitting samples for this and other research projects mentioned below are available at the H&W section of the GDCA's website.

Beyond the Dane-specific research mentioned above, samples from Great Danes are also requested for multiple breed research in the areas of osteosarcoma (both the Broad Institute & Van Andel Institute), Wobblers (Van Andel Institute), & autoimmune disease (University of Utah). In 2010 Carmen Battaglia requested survey information from any & all owners who have experienced bloat/ torsion (GDV) and Great Dane owners were encouraged to participate in this online survey in the hopes the information would suggest a new line of attack to this grave disease. Results of the survey are still limited and publication is pending, however nothing in the survey suggests new lines of research. Currently all potentially productive lines of research into GDV have been exhausted and until there are new avenues suggested, more research dollars committed to this area cannot be recommended, despite the fact this is a significant Dane disease.

REPORT FROM THE 2010 NA-TIONAL ECHO CLINIC: The 2010

echo clinic was again administered by Dr. Bill Tyrrell and he reported similar results as seen in recent years. A total of 68 Danes received echocardiograms with nearly half (32) presenting with abnormal results. Dilated cardiomyopathy (DCM) did NOT predominate in the abnormal results, but rather mitral valve disease was the most commonly reported heart problem (as it has been in the past clinics). The typically young age of those Dane enrolled in this clinic may well result in an under-reporting of DCM, but now we have several sequential vears of data from the national to suggest heart problems in this breed are not limited in adults to DCM. A written report with detailed information on the clinic is pending and will be posted at the website and published in the GDCA Quarterly Bulletin.

AFFORBALE ECHOCARDIO-

GRAMS: A committee project spearheaded by Margaret Shappard the past two years to identify and expand opportunities for Great Dane owners to have access to more affordable (\$200 or less) echocardiograms has met with limited success. Surveys were set out to all affiliates in 2009 & again in 2010 to ascertain their interest in and needs to successfully host echo clinics. Fewer than 10 surveys were returned, so it would appear the majority of our affiliates do not currently have an interest in hosting such health clinics. The GDCA will continue to host an annual two-day affordable echo clinic at the National Specialty sponsored by the CT. There are a few affiliates managing to hold such clinics without requesting outside funding, and any affiliate club which would like to request funding for holding health clinic(s) can do so by writing the CT directly. Some veterinary university programs offer affordable echocardiograms as part of research, and echo clinics are occasionally sponsored by all-breed dog clubs or other such associations. These options are still too limited to adequately service the Dane population and the needs of the breed as to heart health suggest strongly that echocardiograms are vital to identifying various forms of heart disease in individual Danes as well as are an important avenue in improving breed health. SO this issue rightfully needs to be revisited when a useful option presents itself.

DONOR ADVISED FUND & FUND-ING RESEARCH: The last given balance in the DAF is \$13,766.87 with no funding obligations currently pending. The Canine Health Foundation routinely sends requests for funding consideration, but no recommendations for specific funding using the DAF is being made at this time. Note the DAF is used to specifically fund CHF grants.

REVIEW OF OTHER UPCOMING RESEARCH OPPORTUNITIES: |

have the most recent research brochures listing pending research and requests for funding from both for the Canine Health Foundation as well as the Morris Animal Foundation. There are many intriguing write-ups and certainly a lot of very worthy research generally offered, however given the current economic atmosphere where reduced research dollars are available, I am simply monitoring requests for funding, while seeking specific future opportunities that promise to provide some practical clinical advance for the Great Dane or can expect to provide breed-specific research opportunities (and in particularly those diseases of major concern to Great Dane owners and breeders. The top health concerns in the breed, those major conditions that lead to death prior to the natural lifespan of the Great Dane (and/or cause serious chronic disease & catastrophic health costs), would certainly include specific cancers (osteosarcoma, lymphosarcoma and hemangiosarcoma), gastric dilatation-volvulus (GDV=bloat/torsion) and heart disease (specifically if not exclusively dilated cardiomyopathy (DCM)). These three arenas: heart disease, specified cancers and & bloat/torsion constitute the diseases most commonly reported as fatal for this breed. Added to these area, orthopedic diseases that afflict our young dogs (e.g. HOD, Wobblers), along with immunemediated diseases (which includes thyroiditis & Addison's), are areas of large concern. There are many active grants (most fully funded) covering many aspects of cancer research & Danes are participating in relevant studies by providing samples. There is no current research available studying the underlying causes of GDV (which appears to be more a structural and mechanical disease than something directly "genetic,") and there is no pending work on GDV that is focused on offering prevention

potential other than the current recommendation of utilizing gastropexy surgery (to both prevent death from torsion as well as to treat dogs suffering from bloat/torsion). Several projects involving DCM are currently supported by the GDCA & the researchers in question are coordinating with colleagues in Europe on this topic. Other research focusing on heart disease such as mitral valve dysplasia and aortic stenosis would be of use to this breed. Currently work to improve thyroid testing is underway, as is a project to identify underlying genes (which may well have an impact on other autoimmune endocrine diseases, Addison's included). Our Addison's project is stymied by lack of participation: I personally receive several calls a month from owners of Addison's Danes, but unhappily few dogs are actually entered into the ongoing study at UC Davis (despite the ease of such a step provided by the researchers). A diagnosis of Addison's is catastrophic for most owners as can end in rehoming or even euthanasia of Danes with manageable disease at times simply due to the costs of required medications. I receive routine pleas from Dane owners for financial support to be able to keep their dogs. The GDCA supported a breed health & welfare survey in 2001-2003 through the office of Dr. Margaret Slater of Texas A&M University. This provided a wealth of very robust data (i.e. accurate, reliable information) about the state of health in our beloved breed. A decade has now gone by since that survey was initiated. When the idea of repeating this survey was revisited, discussion of the board and this committee ended with the consensus that doing such a health survey once a decade would be the best approach and, when possible, employing the same research would be most efficient. However the CHF now offers a free online survey to all AKC breeds via their parent club and the option exists to take this op-

portunity to do a less formal update between formal health & welfare surveys. The advantages to this free option seem obvious, less so the drawbacks, which would include superseding very accurate data with less rigorous results, leading to confusion both in the fancy and as to research priorities. If the board is interested, Dr. Slater could be contacted to discuss the details (cost, timeline, etc.) of repeating her original work for the GDCA starting in 2011. This committee is concerned about the guestion of owner/breeder education as to health/welfare issues as well as research opportunities. A lot of valuable information on managing health & breeding concerns, despite being widely available, does not seem to routinely end up in the hands (so to speak) of our constituency, particularly those either new to the fancy or disconnected from such organizations as the affiliate clubs. This is in part a result of the overwhelming amount of information available in this information age, which adds to the layman's problem of sorting out the "sheep from the goats" when trying to discern which source (which website) has reliable information. But reviewing what is available through the GDCA and its organs (e.g. affiliates, website) is germane. Certainly the GDCA website should be the first stop for all when "shopping" online for information on the breed. And we all, as individuals or representatives of various clubs & other dog fancy venues, should do what we can to aid others in their pursuit of useful and factual information on various aspects of owning & breeding Great Danes when contacted. The GDCA has in generally taken a conservative approach when providing information to the fancy, erring on the side of too little rather than too fanciful, opiniondriven "FAQS" at its website which is as it should be. However I am interested in (carefully!) expanding the H&W section of the GDCA website to include useful public information in

areas where many times a month I am contacted with the same/similar questions on a given topic (which also can be time-consuming). Beyond answering all who call or email me, I also strive to insure that timely information is disseminated throughout the informal system of internet lists & websites focused on the breed. My thought here is that good information is still singularly useless if it does not reach its core audience. So I both encourage experienced members to suggest such areas of expanded information, and I also encourage others involved in Dane education to see what they can do to find new avenues to disseminate valuable information to the broad spectrum of Dane owners we must serve.
