



I would like to dedicate this quarter's President's letter to an explanation of the action taken by the Board at our January meeting regarding changes to the GDCA National trophies. As many of you already know, these trophies are important, but costly. In addition to the overall cost of the trophies, we are also facing the loss of the annual contribution from Purina for the Futurity (approx \$6,000 per year). As part of its fiduciary duties the Board has, on numerous occasions tried to find ways to reduce the expenses without reducing the quality of the trophies. This past year Jean Dinkins (National Trophy Chair) and Kathy Munyan (GDCA Treasurer) spent a great deal of time looking at the current trophies and several different options and presented the Board with their suggestions during the January meeting. As a brief background, each year the GDCA Trophy Chair is responsible for preparing and delivering a total of 524 trophies. This number includes all trophies for conformation, performance and non-regular classes as well as the Futurity and Top 20. The chart below gives the breakdown of the expenses and revenues for the past 3 years.

As you can see we have some consistent numbers which reflect a yearly expense to the GDCA and the Division of \$24,139.34 (average of 3 years data). Jean and Kathy came up with what the Board felt to be some good options to reduce the overall cost of the trophies without reducing the quality of those trophies. Following a lengthy discussion of all options, the approved changes are as follows:

- Select Dog/Bitch will be changed from the current acrylic to the same style as Best of Winners with the addition of a Select Dog/Bitch banner;
- All first place trophies will be changed to the existing 2<sup>nd</sup> place trophies (medallion on flat wooden base as opposed to upright);
- 2<sup>nd</sup> thru 4<sup>th</sup> place trophies will be changed to 2 ½" pewter medallion with ribbon loop and appropriate colored ribbon.

These changes will reflect in a savings of \$13,000 and change. We also approved changing the judges boxes and outgoing Board member boxes to a smaller box with a 2 ½" medallion instead of a 3 ½ " medallion which saves an additional \$285 and change. With these changes we will reduce the cost of the trophies to the \$23,000 range and if the trophy donations remain the same the cost burden to the GDCA and Division will reduce to a \$13,000 range. We are also working on creative ways to increase our trophy donations but feel that we have at least addressed the costs of the trophies in a positive manner. 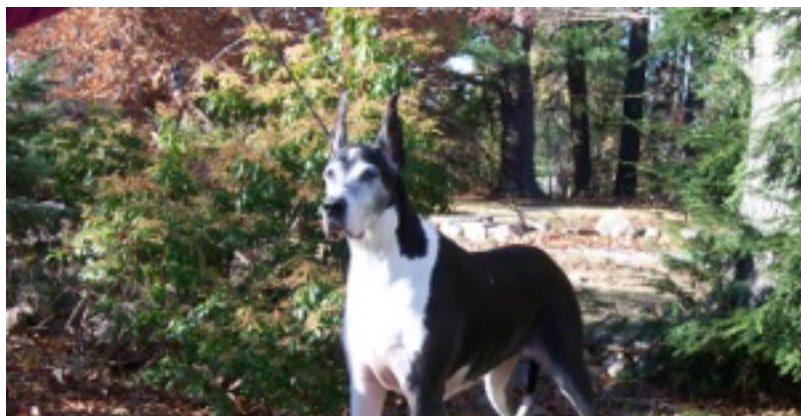

The OFA Champion of Health program began in 2006 to award a dog who has significant accomplishments in the ring at the national level, field, as a working dog or as a producer and has the full complement of appropriate health screenings. OFA recognizes the Champion of Health with an engraved medallion and a \$100 donation to the Great Dane Club of America's Donor Advised Fund at the AKC Canine Health Foundation.

OFA has named **CH Davisdane's Dare to be a Duck, CD, BN, RN, CGCA, ROM, HOF** the **Great Dane Champion of Health for 2014**. Daffy's accomplishments are many. She was the first mantle to finish her championship entirely from the Bred By Exhibitor class, the first recorded ROM mantle, and the first mantle to enter the GDCA Hall of Fame as a producer.

Daffy produced seven Champions, six who have their CHIC certificates. Her daughter, CH Davisdane LongVue Abigail, was Best of Winners at the 2010 National, where another daughter, CH Davisdane's Rubber Ducky You're the One, BN, RN, CGCA, was Best Puppy in the Futurity. Daffy earned her CD at the age of 9-1/2 with a second place in all-breed competition, and her CGCA at almost 10 years of age.
