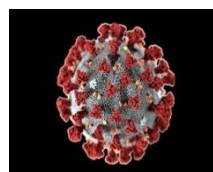

We are pleased to announce that the Great Dane Club of America & The Great Dane Club of America Charitable Trust are continuing the \$75 reimbursement for echocardiograms for **GDCA and Affiliate Club Members** for exams performed in 2022. Guidelines for participating are listed below. We would like to thank Darryl

Pitts for taking the helm as the Gatekeeper for this program.

- 1) The GDCA Charitable Trust will reimburse (subsidize) OFA advanced cardiac (echocardiogram) studies for GDCA and Affiliate Club members in the amount of \$75.
- 2) **Limited to ONE ECHO PER DOG EACH YEAR for either INITIAL or FOLLOW UP Echocardiogram. \*\* (Updated April 2022)**
- 3) Great Dane must be one of seven acceptable colors as recognized by the breed standard.
- 4) Echocardiograms performed at GDCA National will be excluded as they are already subsidized and offered at a reduced rate to participants.

I am expecting the paperwork from two additional individuals who are applying to be breed mentors. I will update you as their applications are submitted to the Breed Mentor Committee.

If there are others that have the necessary qualifications to become a breed mentor please contact me and I will forward you our application forms.

The position of a breed mentor brings with it the responsibility to direct individuals that are aspiring to become judges of our breed in a direction which reflects the attributes which we hold most dear in our beloved Danes. Many of the readers of this article have benefited from the guidance of a breed mentor during their formative years in our breed. It is an invaluable tool as one starts to make decisions about their personal breeding programs.

As many of you are aware the current approval system of additional breeds for judges has changed a great deal since its earlier forms. The need for these individuals to obtain an approved breed mentor becomes even more important.

#### **Echocardiogram Subsidy Program**

#### **Irish Spotting Gene Study – Update from Mary Anne Zanetos**

UC Davis – Veterinary Genetics Lab has tested nearly 200 Great Danes for MITF-LP, the length polymorphism associated with the piebald spotting/Irish pattern. It is clear that the piebald “S” locus does not behave in the manner suggested in the previous literature, namely that there are 3 alleles, S, sp, and si that accurately predict phenotype and outcome of breedings. Most Great Danes included in the study tested as 31, 35 or 36. Each individual has these in pairs, e.g. 31/35, 35/35, 35/36 with these being the most frequent combinations.

In comparing the results of genetic tests to the photographs, it is clear the same MITF-LP results are not always associated with the same pattern of white markings (as one might have expected).

So VGL did further specialized testing. What they found was the same MITF length could be produced by several different sequences of alleles; this will be investigated further. So far 36 Great Danes homozygous for MITF-LP (35/35) have been tested to try to determine

whether the Irish pattern relates to a specific or unique sequence within this length.

VGL will continue to tease out the relationship between sequence (within LP) and phenotype. They would like to study pairs of dogs already enrolled in the study, along with their offspring (which will submit test to be conducted) to see if predicted pattern/markings based on genetic results were observed in their offspring.

Bottom line: Pattern inheritance in the Great Dane is different and less predictable than other breeds where Irish Spotting pattern is seen. It seems to be far more complex and will require further research and perhaps new tests to understand its inheritance and hopefully develop genetic tests that enable selection of mating pairs to maximize and maintain the desirable Irish pattern.

This study is now closed. Results and finding will be presented following further analysis.

#### **Osteosarcoma Study – NC State University**

##### **XRADIOS: Palliative-Intent Radiotherapy +/- XRD-0601 for Canine Osteosarcoma**

Dr. Michael Nolan is conducting an innovative study at UNC. This study is somewhat unique in that it does not require amputation of the affected leg. The purpose of the study is to determine whether the addition of a drug which targets a genetic abnormality in these tumors can increase the effectiveness of treatment over radiation therapy alone.

Dr. Nolan's osteosarcoma study is fully enrolled. He is very grateful for the financial support from GDCA and GDCA Charitable Trust and to several GDCA members who distributed information on the study at various shows. The VISA cards provided really helped defray travel cost of some of the dogs enrolled. Results from this study will be shared when available.

#### **AKC – Canine Health Foundation – Donor Advised Funds**

The GDCA board approved our proposal to become sponsors of the Canine Health Foundation's Hemangiosarcoma Initiative. The

GDCA will be listed among the other parent clubs on their website. We also approved \$2,500 grants from our donor advised funds to be applied to each of the following current Hemangiosarcoma studies:

### **A GD3 Nano-scaled Liposomal Cancer Vaccine Clinical Trial for Canine Hemangiosarcoma**

#### **ABSTRACT**

Hemangiosarcoma, a cancer of the lining of blood vessels, is a devastating cancer of numerous large breed dogs. Hemangiosarcoma (HSA) often presents as an emergency in otherwise healthy individuals with evidence of acute abdominal bleeding or bleeding around the heart. Owners are often distraught by the unexpected news. HSA is rarely diagnosed in the early stages as imaging of the abdomen is often not included in the yearly physical examinations. Sadly, most dogs die within 2-3 months of treatment because of the advanced stage (splenic rupture) of the cancer and spread to the lungs and other organs. The addition of chemotherapy improves survival times for dogs with splenic HSA, but only on average 145-180 days. Regrettably, there has been little improvement in survival in dogs with HSA in the last 30 years. However, modifying how the body's immune system reacts to the cancer offers new hope for improved survival. This research proposes to use a vaccine that investigators have extensive experience with in canine melanoma and bone cancer (osteosarcoma). New preliminary research indicates that the vaccine target, GD3, is present in HSA, similar to melanoma and osteosarcoma use. All dogs will get standard-of-care treatment and randomized into two groups - one getting the GD3-based vaccine and the other group receiving placebo. Since melanoma and osteosarcoma have shown promising results, investigators hope that dogs with HSA respond similarly to the vaccine.

### **Towards Curative Outcomes in Canine Hemangiosarcoma -**

#### **ABSTRACT**

Canine hemangiosarcoma is the most aggressive cancer seen in all dogs, but disproportionately affects older, large breed dogs. Despite aggressive treatment with surgery

and chemotherapy, more than 50% of dogs die due to metastatic spread of their cancer within 6 months and no significant advancements in the treatment of hemangiosarcoma have occurred in over 30 years. Several challenges have hindered improvements in outcomes including limitations in the capabilities of current imaging and/or blood-based markers to detect early relapse/metastasis, gaps in current understanding of the molecular biology of hemangiosarcoma, and a lack of effective therapies that effectively alter the aggressive metastatic behavior of this cancer. A nation-wide clinical trial for 400 dogs with splenic hemangiosarcoma seeks to deliver curative outcomes for dogs with this disease. With collaboration from AKC Canine Health Foundation, dog-owning families from outside the geographical enactment of 30 Ethos veterinary hospitals can join the trial to receive care, and to conduct genomic correlative studies with two internationally recognized scientific teams to gain critical new knowledge necessary to propel the field to this future goal of curative outcomes. Researchers will utilize a patient-forward approach and leverage genomic insight into hemangiosarcoma to propose and answer the following questions: (1) are there molecular biomarkers that predict prognosis in dogs with this disease?; (2) can we define genomic subgroups of dogs with hemangiosarcoma who are most likely to benefit from specific anticancer drugs?; (3) can we define new therapeutic approaches to prevent the spread of this cancer? This approach follows the road map used in transforming childhood leukemia from a fatal diagnosis to a commonly cured disease. By leveraging the strengths of a unique and multidisciplinary team of clinicians and scientists, this canine hemangiosarcoma study will lay the foundation for accelerating drug development and improving patient outcomes for dogs with this devastating disease.
